Definitions & Acronyms

- SPOs Social Purpose
 Organizations. SPOs contribute
 to solving pressing social,
 cultural and environmental
 challenges across Canada
- IRP Investment Readiness Program
- Funding partners/Community Funders – organizations that will receive grant applications through the IRP

- Expert-Service providers Organizations or consultants
 that provide resources, training,
 mentoring, and other learning
 opportunities to social-purpose
 organizations to move towards
 investment readiness
- SI/SF Social innovation/social finance
- GHG Green house gas emissions

What is Social Finance?

Social Finance is a repayable investment that generates a positive social, environmental, and/or cultural impact.

Investment Readiness Program

Funded by the Government of Canada, the goal of the program is to provide **capacity-building funding** for organizations, so they can be in a better position to eventually be part of a project pipeline and secure investment funding



How Can Social Finance Be Used?

- Purchase an asset
- * Spend now to earn revenue later
- Spend now to prevent costs later
- *Launch a social enterprise
- * Scale an existing social enterprise

- Legal negotiation



Investment Readiness Program – Projects Funded in Round 2

St. James Town Community Co-op And Central Neighbourhood House (Toronto, ON)

Amount funded: \$73,640

Project: The OASIS Food Hub (Social Enterprise) is an ecological food system model for neighbourhoods that holistically integrates the full food cycle from production to procurement, processing, distribution, waste management, and land regeneration. Experts, Co-op members, and residents developed the OASIS Food Hub model to deliver the human right to food in St. James Town and other low-income neighbourhoods facing systemic food insecurity, while also creating a sustainable, climate-resilient and socio-economically just urban food system.

(Financed through Canadian Women's Foundation)

Investment Readiness Program – Projects Funded in Round 1

Community Seniors Co-operative Ltd. (O'Leary, Prince Edward Island) Amount funded: \$ 10 000

 Project: Develop and eventually operate a 40unit community care home, which will assist seniors and adults challenged with activities of daily living. (Financed through Community Foundations Canada)

Investment Readiness Program – Projects Funded in Round 1 Continued

Coopérative Celcius (Montreal, Quebec) Amount funded: 95 000 \$

 Project: Develop a pilot project that consists of installing renewable and collective energy infrastructures in the streets of Montreal with the aim of reducing GHG emissions caused by heating buildings. (Financed through Le Chantier de l'economie sociale)

Successes for Co-operatives in the Previous Application Cycle

59 co-operatives approved for funding through the IRP >\$3.46 Million in funding

CWCF Grant Programs

(1) Technical Assistance Grants

- For Worker Co-ops and certain Multistakeholder Co-ops
- To hire expert consulting assistance on any aspect of co-op management or governance; can be for start-up or conversion
- E.g., feasibility, marketing, financial administration, expansion, conflict resolution, compensation, legal issues
- Must be CWCF Member, or commit to join
- Up to \$3,500 / increasing soon to \$4,000



Technical Assistance Grants (continued)

- The value of the grant needs to be demonstrably able to make a difference to the need being addressed
- Match between the co-op's need and the skills of the consultant
- Working with a member of CoopZone is encouraged.

(2) CWCF Racial Justice Grants

- •Allocated to projects led by individuals who are Black, Indigenous or other People of Colour (BIPOC), and groups which are majority BIPOC
- •Projects must support racial justice in the worker co-op sector in Canada via promotion, development and/or education initiatives
- •Successful applicants must commit to completing a short funding impact assessment survey and project report upon project completion
- •Up to \$2,000.



JEDI Social Acquisition Project

- Not a grant opportunity, but... this CWCF Ecosystem Builders Project promotes the opportunity of social acquisitions/ conversions to Social Purpose Organizations (including worker co-ops) with JEDI* people and groups.
- It will provide education for equity-deserving groups (buyer-side and seller-side audiences).
- It will create a list service providers.

(*JEDI –Justice, Equity, Diversity, and Inclusion. Also known as Equity-Deserving / Equity-Denied Groups, including BIPOC, women, people with disabilities, LGBTQ+, and youth)



Overview: Co-operative Development Program (CDP)

- Established in 1992
- Expression of our long-standing commitment to co-operatives
- ➤ Unique, pan-Canadian
- ≥\$500K disbursed in 2022
- ➤ Since inception, over \$3.6M in grants to 239 co-operatives





What do CDP grants cover?

- ➤ Grants cover costs associated with co-op business development:
 - > Feasibility studies
 - ➤ Market research
 - **>** Business planning
 - ➤ Member engagement efforts

Things to Consider When Applying to CDP

> Demonstrated need for the project/initiative

> Leadership and capacity to deliver on proposed initiative

- Evidence of partnerships and "skin in the game"
- ➤ Connection of proposed initiative to longer-term sustainability

➤ Alignment with our Social Impact Framework










Landscape
