



- Poor financial literacy culture; financial & mental health crisis among BIPOC women, youth & new immigrants. (Color of Poverty Factsheet)
- Racialized women earn 32% less; 41% of "chronically poor" immigrants have degrees. (Statistics Canada; Color of Poverty)
- Black & Indigenous Women Entrepreneurs have least access to capital. (WEKH SOWE Report 2024)
- 47% of Canadians live Pay cheque to Pay cheque. (Equifax Canada Report, 2024)






